# Bylaw No. 1477-18 Temporary Borrowing Bylaw

Renee Stoyles, Director Finance stated that the Town is required to replace Bylaw 1358-10 passed August 24, 2010 as part of the transition of bank accounts from the Lakeland Credit Union to ATB Financial. The amount of the maximum borrowing in this new Bylaw is \$2.5 million which is \$63,935 higher than the amount previously authorized in the Bylaw with the Lakeland Credit Union. Bylaw 1358-10 (Lakeland Credit Union) will be repealed with the passage of this new bylaw.

## 2019 Draft 1 Operational Budget

Renee Stoyles, Director of Finance, presented Draft 1 of the 2019 Operational Budget for Council Review. She noted that Draft 1 has a deficit of \$819,561.00. Some items of note were: Reduced revenue in the amount of \$319,459.00 due mainly to not using funds from the Regional Community Development Agreement to aid in balancing the Operating Budget as well as numerous revenue areas that have decreased. Overall Expenses have increased by \$122,798.00

## 2019 Draft 1 Capital Budget

Renee Stoyles, Director of Finance, presented Draft 1 of the 2019 Capital Budget for Council review. She noted that there were some amendments made to reflect allocation of funds for the capital items identified in the long-term Capital Budget which were noted with the passage of the 2018 Capital Budget. Other items from 2018 were also carried forward that will not be completed this year. Since the carried forward items were all funded in 2018, the amounts carried forward will be funded from reserves or deferred revenue.

Discussion ensued.

Council directed Administration to make some adjustments and bring it back for discussion.

Councillor Brian McEvoy declared a conflict and left the meeting at 6:51 p.m.

A Staff Request for Decision was presented for a Capital Purchase for the shortfall from the purchase of an Ambulance. Jay Melvin, Deputy Fire Chief, stated that due to capital funding shortages, the 2018 capital purchase for the replacement of one Type 1 Ambulance has a funding shortfall of \$50,000.00. Bonnyville Regional Fire Authority (BRFA) Board has directed BRFA Administration to make a submission to the Town of Bonnyville and the M.D. of Bonnyville for 50% from each municipality.

Discussion ensued.

Possible Alberta Community Partnership Grant for ICF Project with the M.D. of Bonnyville Administration received a telephone call from the Municipal District of Bonnyville advising that they have received an Alberta Community Partnership (ACP) Grant for setting up their Intermunicipal Collaboration Frameworks (ICF) with the Summer Villages located within the M.D. of Bonnyville; there is a good possibility that they will not spend all of these funds.

Possible Alberta Community Partnership Grant for ICF Project with the M.D. of Bonnyville As there is a possibility that there will be unspent funds remaining from this partnership grant that they received, they are querying whether the Town of Bonnyville would be interested in utilizing these funds in conjunction with them for commencing with establishing an Intermunicipal Collaboration Framework (ICF) between the Town of Bonnyville and the Municipal District of Bonnyville.

The Province of Alberta will be required to approve a change in their Alberta Community Partnership Grant Application to include the Town of Bonnyville if we wish to take advantage of this.
