#### **BYLAW**

Bylaw No. 1511-21 Supplementary Assessment Bylaw The Supplementary Assessment Bylaw is passed annually in the Town of Bonnyville to reflect the value of an improvement that has not been previously assessed or the increase in the value of an improvement since it was last assessed.

The Municipal Government Act states in Section 313:

313 (1):

If a municipality wishes to require the preparation of supplementary assessments for improvements, the council must pass a supplementary assessment bylaw authorizing the assessments to be prepared for the purpose of imposing a tax under Part 10 in the same year.



# Bylaw No. 1511-21 Supplementary Assessment Bylaw

313 (3):

A Supplementary assessment bylaw or any amendment to it applies to the year in which it is passed, only if it is passed before May 1 of that year.

# Bylaw No. 1509-21 – Amend Land Use Bylaw No. 1447-16

The Planning and Development Department has received an application to amend the land use district on Part SE 17-61-5-W4 in the Eastgate Subdivision area. The amendment to the land use districting is from UR – Urban Reserve District to C4 – Shopping Centre Commercial District.

The purpose for the proposed redistricting is for creation of a commercial parcel. This proposed amendment is consistent with the Eastgate Area Structure Plan Bylaw No. 1354-10.

Letters were sent out to adjacent landowners and agencies notifying them of this proposed change in land use districting. The bylaw will be advertised in accordance with legislation and a public hearing is required to be held.

ICF – Town and M.D. of Bonnyville

The Town and M.D. of Bonnyville have been working on an Intermunicipal Collaboration Framework (ICF), as required by the Municipal Government Act.

As per the MGA, Municipalities that share a common boundary, unless they are members of a Regional Growth Board, must pass an ICF by April 1, 2021. ICF's must be reviewed every 5 years and must be passed by resolutions of both Councils. The ICF between the Town and MD of Bonnyville needs to take into account services that benefit residents of more than one Municipality, identify which municipality provides the services. outline how services are delivered and funded, and include a process for resolving any disputes. The ICF between the Town and MD of Bonnyville provides a base funding amount of \$1.5 Million Dollars annually for the provision of services in the Town of Bonnyville that benefit the residents of the MD of Bonnyville. The ICF recognizes that the MD of Bonnyville contributes to the RCMP General Investigative Services Unit through the base annual funding amount. In addition, the ICF reaffirms the MD's continued contribution to the Centennial Centre. Fire Authority and other commitments through separate funding agreements. The ICF also recognizes the importance of the ID 349 funding formula that was recently approved by the Province, which will benefit residents of our Region through amalgamation of the ID into the MD of Bonnyville, with revenues to be distributed as per the formula with the Province and Municipalities. This funding will be critical to the future Infrastructure deficit funding of the Town of Bonnyville.

# National 3-digit Suicide Prevention Hotline

M.P. Stubbs is requesting that Council consider passing a motion of support for the 988 Crisis Line initiative and to send letters of support to our local elected representatives and neighboring Municipalities.

WHEREAS the Federal Government has passed a motion to adopt 988, a National three-digit suicide and crisis hotline;

AND WHEREAS the ongoing COVID-19 pandemic has increased the demand for suicide prevention services by 200 per cent;

AND WHEREAS existing suicide prevention hotlines require the user to remember a 10-digit number and go through directories or be placed on hold;

AND WHEREAS in 2022 the United States will have in place a national 988 crisis hotline;

AND WHEREAS the Town of Bonnyville Council recognizes that it is a significant and important initiative to ensure critical barriers are removed to those in a crisis and seeking help;

NOW THEREFOR BE IT RESOLVED THAT the Town of Bonnyville Council endorses this 988 crisis line intiative;

And that Staff be directed to send a letter indicating such support to the local MP, MPP, Federal Minister of Health, the CRTC and local area municipalities to indicate our support.
