Bonnyville & District Chamber of Commerce – Oil and Gas Show Sponsorship

Administration received a request for the Bonnyville & District Oil & Gas Show (BOAGS) Sponsorship Opportunities from the Bonnyville & District Chamber of Commerce. The 2022 Bonnyville Oil & Gas Show is scheduled to take place on June 15th & 16th, 2022.

Since 2017, after a request from the Bonnyville & District Chamber of Commerce for an increase in funding assistance for the Oil & Gas Show to \$10,000.00, Council approved provision of \$10,000 for this event, which is held every 2 years. Historically, the Oil & Gas Show and the Cold Lake Airshow operate on alternating years and the Town has been sponsoring both events on alternating years for similar amounts. This year, due to previous covid restrictions, both events are slated to be held in 2022.

This year the Town has \$10,000.00 included in the Interim operating budget for this event, which will not be formally approved by Council until Final budgets are passed in April.

Moved by Councillor David Sharun that Council approve the Friends of BOAGS "BEAR level" sponsorship for the Bonnyville & District Oil & Gas Show 2022 at the cost of \$10,000.00.

The Farm Safety Centre offers various programs, including "Safety Smarts", a child safety program aimed at elementary

school aged children in rural schools in Alberta, which includes children in Bonnyville.

As of late 2020, the Province of Alberta ceased grant funding for the Centre, which had accounted for approximately 35% of annual program delivery funds. For this reason, the Centre has been reaching out to Municipalities they serve for assistance.

Although not specifically covered by Town of Bonnyville Donation Policy 15-FN-068, contributing to this organization could fall under Section 4.2.1, 'General exposure and Profile', as well as Section 5.4.4, 'Benefit to the Community'.

Letter of Support – BRFA – Emergency Management Exercise Grant Administration received a letter from the Bonnyville Regional Fire Authority (BRFA) Chief Dan Heney requesting Council's support for a grant they are applying for from the Forest Resource Improvement Association of Alberta (FRIAA) for a tabletop disaster exercise.

FRIAA has invited the BRFA to apply for a Training Grant for approximately \$15,000.00 for a tabletop exercise. This tabletop exercise will be based on a one-day scenario with round table exercise in the morning and debrief activities in the afternoon. The contractor will provide a report with observations and recommendations based on the outcome of the exercise as part of the project deliverables.

The attendees that would be invited to participate would include RCMP, Agriculture and Forestry representatives, BRFA, the Town Director of Emergency Management (DEM) and Deputy DEM.

The grant would cover 100% of all costs other than the salaries of those who participate, which would be covered by their respective organizations.

Rebates can be received for the installation of EV changing stations for use by the public and municipal vehicle fleets on municipally owned land and community gathering places such as recreations centres, libraries, town halls, curbside locations and more.
