Approval of Changes to Library Bylaw Schedule C

Administration received Bonnyville Municipal Library Bylaw Schedule C, which was passed by the Library Board in accordance with section 36 of the Libraries Act. The change to Schedule C is for the removal of late fines.

Section 37 of the Libraries Act requires the Municipal Library Board on passing of a Bylaw Under Section 36 to "forthwith forward a copy of the Bylaw to the Council of the Municipality". In addition, Section 38 of the Act says that "The Council of a Municipality may disallow a Bylaw passed by a Municipal Board it has appointed."

As such, a resolution from Council to approve (not disallow) the Bylaw Schedule C amendments is required.

4 Wing Cold Lake 2022 Air Show Sponsorship

Administration presented Council with the agreement from 4 Wing Cold Lake requesting commitment from the Town for the 2022 Air Show Sponsorship as an Entertainment Sponsor. The 2022 Air Show is scheduled to take place on July 16th and 17th, 2022.

The Town of Bonnyville has previously sponsored this event in 2016 at a cost of \$5,000 and in 2018 at a cost of \$7,000, for VIP Chalet packages (cost to set aside a certain number of seats in the VIP tent, without Sponsorship recognition). If the Town were to continue past practice, a Gold level Chalet package, at \$12,000, would enable the Town to send 60 people over 2 days to the event.

The request from 4 Wing Cold Lake for the 2022 Air Show is for the Town to become an Entertainment Sponsor at a cost of \$20,000. This level of event participation, at a formal 'sponsorship' level, includes a "Bronze" level chalet package (15 tickets for the weekend) plus several other benefits including corporate logos on volunteer T shirts, attendance for 2 people at the Wing Commander's tent, etc.

This year the Town does have \$20,000 included in the Interim operating budget for this event, which was added after the Air Show Budget delegation presentation last September. These funds will not be formally approved by Council until Final budgets are passed in April.

Redeployment resources can include up to 10% of Members from any municipal contract partner, and any municipality from which resources are drawn will not bear the costs directly related to the redeployment
